




# Town Profile: Oldbury

Oldbury is one of six towns in Sandwell. It is situated in the south of Sandwell and contains the wards of Bristnall, Oldbury, Langley and Old Warley. Oldbury borders Birmingham and Dudley to the South and Southwest.










The population of Oldbury town grew by 8.5% between 2011 and 2021. Oldbury ward had the largest percentage change of all the wards within Oldbury town, growing by 14.7%. Looking at broad age groups, the 20-64 group in Oldbury town had the largest increase, of 5.3% over the ten-year period.

### Ethnicity, 2021




47% of Oldbury's population are from ethnic minorities. This is similar to Sandwell (48%), but significantly higher than England (27%). The Black/African/Caribbean/Black British category for Oldbury town is double the percentage for England.






The number of full-time employees in Oldbury town is slightly higher than Sandwell. The highest percentage of unemployment residents is in Langley (4.9%) and the lowest in Old Warley (3.2%). Old Warley also has the highest percentage of retired residents, with 22.7% compared to 17.4% across Sandwell.

9.2% of residents in Oldbury town provide unpaid care, with 2.9% providing 50 hours a week or more. This is slightly lower than Sandwell (3.2%).

The percentage of residents who are disabled under the Equalities Act is in line with Sandwell, at 18%. The percentage of residents who are long-term sick or disabled is in line with Sandwell at 22.9%.


The percentage of residents with no qualifications is lower in Oldbury town (27%) than in Sandwell (29%). The ward with the highest percentage of residents with a level 4 qualification or above is Old Warley with 29%, compared to 23% for Sandwell.

7% of households in Oldbury town have no resident who speaks English as a main language, compared to 9% in Sandwell. This is particularly low in Old Warley (4%) and high in Oldbury ward (11%).

In England, the lower layer super output areas (LSOA\*) are ranked into 10 deciles for Deprivation.

• 50% of the LSOA's Oldbury town are in the 20% most deprived LSOAs in England (Sandwell, 60%)

Oldbury's Income Deprivation Affecting Children Index (IDACI) and Income Deprivation Affecting Older People Index (IDAOPI) Scores are in the 30% most deprived areas in England.

Overall Oldbury is less deprived than Sandwell but more deprived than England and its deprivation score would put it in the 30% most deprived areas in England.






#### **Income Deprivation, 2019**










Income Deprivation Affecting Older People Index, 2019





### Household Composition, 2021



The majority of housing in Oldbury town is owner-occupied (59%). Social renting in Oldbury town is lower than in Sandwell (22% and 27% respectively). Private renting is particularly high in Oldbury ward, with 27% compared to 19% in both Oldbury town and Sandwell.

Overcrowding is slightly lower in Oldbury town (6%) than in Sandwell (8%), however is higher in Oldbury ward (9%).

Household composition within Oldbury town is mostly in line with Sandwell.

Female life expectancy at birth in Bristnall and Langley was statistically significantly lower than England's, but in Old Warley and Oldbury it was similar to England's.

Male life expectancy at birth in Old Warley was similar to England's. In the other three wards it was statistically significantly lower than England's.








#### **Overweight/Obesity in Children**


Prevalence of overweight (including obesity) at Reception, 3-year period 2019/20 - 2021/22




#### Prevalence of overweight (including obesity) at Year 6, 3-year period 2019/20 - 2021/22



The prevalence of overweight (including obesity) at Year 6 is higher in Oldbury town (45%) than England (36%). The rate of emergency admissions for injuries in children under 5 years old is slightly higher in Oldbury town (128.2) than England (119.3), however is still lower than Sandwell (133.4). Oldbury ward is particularly high with a rate of 155.4.

Deliveries to teenage mothers were higher in Oldbury town (1.15%) than Sandwell (1.07%). Low birth weight is in line with Sandwell (9%), however Langley was much higher than the other wards, with 11%.


Incidence of lung cancer is statistically higher than England in both Oldbury town and Sandwell. Breast cancer is much lower, however is higher in Oldbury town than Sandwell. Breast cancer in Oldbury ward is statistically significantly higher than England.

Emergency hospital admissions for heart attack are slightly higher in Oldbury (SAR 116.8) than Sandwell (113.9). This is significantly higher in Oldbury ward (141.9). Emergency admissions for COPD are particularly high in Langley (184.1) compared to Sandwell (157.3).

Looking at deaths from circulatory diseases in the under 75's, Sandwell has a significantly higher standardised mortality ratio than Oldbury town (148.5 and 126 respectively). Old Warley is the ward with the lowest SMR, at 77.8.








#### General Health of Oldbury residents by Age, 2021

About 80% of residents said their health was good or very good. 53% of residents aged 65 and over said they were not in good health. This was similar in Sandwell but higher than for England.


The crime rate per 1,000 residents is lower in Oldbury town (112.7) than in Sandwell (121.7). Oldbury ward has a particularly high crime rate, with 192.8.

Violence and sexual offences were the most prevalent type of crime across all areas. Vehicle crime was highest in Old Warley (14%) compared to 10% in Sandwell. Burglary was highest in Bristnall (7%), compared to 5% in Oldbury town and Sandwell.







### 8. Child Development – Education

The percentage of children achieving a good level of development at the end of Reception is higher in Oldbury town (61.4%) than Sandwell (59.1%). Both are lower than the national figure of 65.2%.

The average Attainment 8 score in Oldbury town is 48.2, which is in line with the national figure. Sandwell is slightly lower with 45.7.

The average Progress 8 score for Oldbury is higher than both England and Sandwell, at 0.24.




